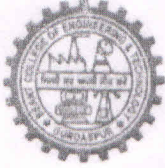

At the outset, Dr R C Gangwar, Coordinator, IQAC welcomed the Hon'ble chairman and other members to the meeting for academic session 2019-20 of Internal Quality Assurance Cell (IQAC) of the college. Thereafter, with the permission of the Hon'ble Chairman, the agenda items were deliberated upon and the following decision were taken unanimously:

Item No. 1.1: Confirmation of proceedings of IQAC meeting for academic year 2018-19.

Decision: The approved proceeding of IQAC meeting for academic year 2018-19 was circulated to its members for information and comments, if any. And, no comments have been received.

So this is confirmed.

Item No. 1.2: Status of admission in first year for academic year 2019-20.

Decision: Dean, academics presented the admission data for academic year 2019-20. It is observed that admission is continuously decreasing on year-by-year basis. However, Dean (Acad.) told that due to CORONA VIRUS pandemic students from outside state could not reach the college in big ways that is why this year admissions are low wrt last year.

Committee has asked the college to devise mechanisms to improve the admissions.

Item No. 1.3: Academic calendar for year 2019-20.

Decision: Dean, academics presented the academic calendars for year 2019-20, and same was implemented in tote.

And it is observed that Punjab Govt. leaves were followed by the college.

So the item is confirmed.

Item No. 1.4: Application for academic autonomy extension for another 5 year as per decision taken by academic council.

Decision: Keeping in view of the benefits of academic autonomy the IQAC is in favor of continuance of this status for another five year. And college has applied for extension of it.

So this item is confirmed.

Item No. 1.5: Minutes of meetings of Department Quality Assurance Committee (DQAC) of different departments.

Decision: Each department has formed its own Department Quality Assurance Committee (DQAC) and conducted regular meetings for enhancement of quality of academic activities in

the respective departments. However, few suggestions have also been given regarding inclusion of extracurricular activities of students in the minutes of the meetings, and also conduct DQAC meetings frequently.

So this item is also confirmed.

Item No. 1.6: Re-admission of students willing to continue their studies after a gap.

Decision: Since college has implemented the decision taken by academic council.

So this item is confirmed.

Item No. 1.7: Migration of students to other institutes as per IKG PTU Migration regulations.

Decision: Since college has implemented the decision taken by academic council.

So this item is confirmed.

Item No. 1.8: To give special golden chance to old students.

Since college has implemented the decision taken by academic council.

So this item is confirmed.

Item No. 1.9: Result analysis after moderation of marks.

Decision: The result analysis for exams Dec, 2018 and May, 2019 were reviewed and approved by academic council in its 9th meeting held on 17/03/2020.

Item No. 1.10: International conference on Materials, Manufacturing and Decision making (ICMMDM 2019).

Decision: An international conference was organized by Mechanical Engg department during 22-23 Feb, 2019, wherein total 41 participants have benefitted.

Item No. 1.11: Official communication through emails created in bcetgsp.ac.in domain.


Decision: Keeping in view of the current CORONA Virus pandemic college has created email accounts of all officials in bcetgsp.ac.in domain name for official communication.

The meeting ended with vote of thanks to the chair.


