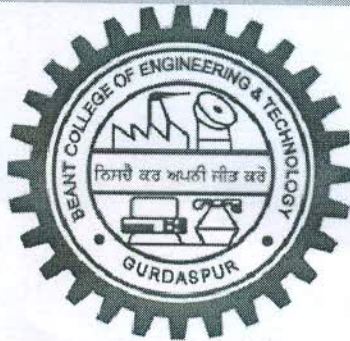

Approval of recommendations of BOS (Department wise) for 1st year syllabus batch-2018 onward.

Decision

Item was presented and recommendations of various BOS were approved department wise as detailed below:-

It was decided that as per previous practice 02 groups should be made (Only for first Year) for all branches.

- 1) Physics Group
- 2) Chemistry Group

A) Department of Computer Science & Engineering : The scheme of B.Tech. CSE 2018 batch onwards and syllabus of Programming for problem solving (BTCS-18101) and Programming for problem solving Lab (BTCS-18102) was approved.

B) Department of Applied Sciences:

It was approved to divide Mathematics Syllabus into 03 categories:-

First Category will consist of Mechanical, ECE, Civil & Chemical Engineering and Course content for math-1 (AMME-18101) and math-2 (AMME-18102) will be same as approved for Mechanical Engg.

Second Category will consist of IT and CSE and Course content for math-1 (AMCS-18101) and math-2 (AMCS-18102) will be same as approved for CSE.

Third Category will consist of Bio-Technology and course content will be math-1 (AMBT-18101) and math-2 (AMBT-18102).

The syllabus of Chemistry will be common to all branches which will be standard syllabus recommended for Chemical Engineering branch (BTAC-18101 for theory and BTAC-18102 for practical).

The syllabus of Physics (BTPH-18101) and Physics Lab (BTPH-18102) will be common to all branches which will be standard syllabus recommended for Chemical Engineering branch.

The syllabus of English (BTHU-18101) and English Lab (BTHU-18102) will be common to all branches which will be standard syllabus.

C) Department of Bio-Technology: The scheme of 1st year B.Tech. Biotechnology 2018 batch onwards was approved.

D) Department of Chemical Engineering: The scheme of 1st year will be same as approved for Mech Engg.

E) Department of Civil Engineering : The scheme of 1st year was approved.

F) Department of Electronics & Communication Engineering: The scheme of 1st year B.Tech. 2018 batch onwards and syllabus of Electrical and Electronics Engg. (BTEC-18101) and Electrical and Electronics Engg. Lab (BTEC-18102) was approved for all 1st year B.Tech branches.

G) Department of Information Technology: The scheme 1st year B.Tech. IT 2018 batch onwards was approved.

H) **Department of Mechanical Engg.:** The scheme 1st year B.Tech. Mech. Engg. 2018 batch onwards and syllabus Workshop/Manufacturing (BTMP-18101) & Engineering Graphics (BTME-18101) were approved.

The scheme and syllabus of M. Tech. Thermal Engineering was approved and it was advised to elaborate the contents of the syllabus with more details.

I) **It was approved that if the student changes/ upgrades the branch then he/she will be required to clear the bridge course. The curriculum/syllabus for the bridge course will be the difference in syllabus. There will be no credit for this bridge course. Satisfactory report from the concerned teacher/faculty will be sufficient to clear the bridge course.**
